**THE WEST VAUGHAN EMPLOYMENT AREA SECONDARY PLAN MODIFICATIONS**

On September 7, 2010 Vaughan Council adopted the city's new Official Plan. It is made up of Volume 1, which provides overall policy guidance to regulate the City's growth and development to 2031; and, Volume 2, which provides more detailed policies for specific areas or sites and five new plans based on recent studies being the North Kleinburg-Nashville Secondary Plan, the Vaughan Metropolitan Centre Secondary Plan, the Yonge-Steeles Corridor Secondary Plan, the Woodbridge Centre Secondary Plan and the West Vaughan Employment Area Secondary Plan.

Council has previously considered modification requests to Volume 1 (September 2011) and Volume 2 (March 2012), originating from government agencies, the public and other stakeholders. The purpose of this meeting is to provide Committee of the Whole with a report that addresses modifications to the West Vaughan Employment Area Secondary Plan and provides recommendations respecting the modifications.

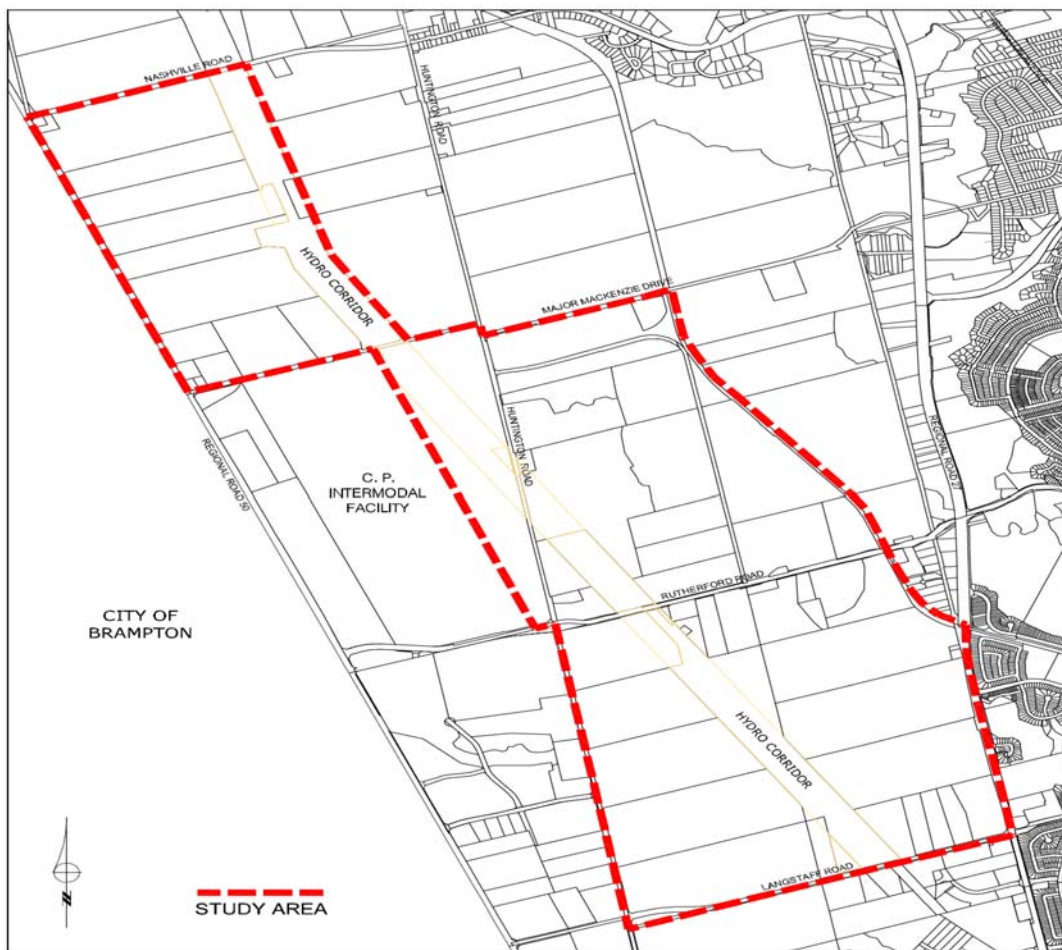

**APPEAL PROVISIONS**

Please note: If a person or public body does not make oral submissions at a Public Hearing or make written submissions to the City of Vaughan before the Draft Official Plan is adopted:

1. the persons or public body is not entitled to appeal the decision of the City of Vaughan Council to the Ontario Municipal Board; and
2. the persons or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless in the opinion of the Board, there are reasonable grounds to add the person or public body as a party.

As OMB appeals have been filed, once adopted by Council, the revised WVEA Secondary Plan will be forwarded to the Region for review prior to being considered by the respective Approval Authority.
