Item 10, Report No. 7, of the Committee of the Whole, which was adopted without amendment by the Council of the City of Vaughan on February 17, 2015.

**10 ASSUMPTION – NORTH BATHURST PHASE 2 SUBDIVISION
 PLAN OF SUBDIVISION 65M-4091 (19T-95044)
 WARD 4, VICINITY OF BATHURST STREET AND RUTHERFORD ROAD**

The Committee of the Whole recommends approval of the recommendation contained in the following report of the Commissioner of Public Works and the Director of Development Engineering and Infrastructure Planning Services, dated February 3, 2015:

Recommendation

The Commissioner of Public Works and the Director of Development Engineering and Infrastructure Planning Services recommend:

1. That Council enact the necessary by-law assuming the municipal services that are set out in the Subdivision Agreement for Plan 65M-4091, and
2. That the Municipal Services Letter of Credit be reduced to \$5,000 to guarantee the completion of minor streetscaping items to the satisfaction of the Development Planning Department. Upon completion of the streetscaping deficiencies, the Municipal Services Letter of Credit will be released.

Contribution to Sustainability

The municipal services recommended for assumption in this report have been designed and constructed in accordance with City standards which include consideration for sustainability.

Economic Impact

Upon assumption of this subdivision, approximately 1.9 lane kilometers of roadway and associated municipal services including sewers, watermain, street lighting, streetscaping, sidewalk, etc., will be added to the City’s network of infrastructure. This additional infrastructure is valued at \$1,903,570 and will incur the normal expense associated with annual operation and maintenance activities of approximately \$37,440 shown on the following chart:

Communications Plan

The pertinent City departments will be notified of the assumption of this subdivision.

Purpose

The purpose of this report is to inform Council that the municipal services constructed pursuant to the Subdivision Agreement between North Bathurst Developments Ltd. and the City are complete and can be considered for assumption by the City.

Background - Analysis and Options

The North Bathurst Phase 2 Subdivision, Plan of Subdivision 65M-4091 is a residential development comprised of 152 single lots, located south of Major Mackenzie Drive West and west of Bathurst Street in Ward 4 as shown on Attachment No.1.

The subdivision agreement with North Bathurst Developments Ltd. was executed on June 13, 2008, and the Plan of Subdivision was subsequently registered on September 29, 2008. The construction of the roads and municipal services in Plan 65M-4091 was considered substantially complete on January 9, 2013.

The Developer has maintained the municipal services in the subdivision during the required minimum thirteen month maintenance period and has rectified all deficiencies. All documents required for assumption have been received and the grading of all lots in the subdivision has been certified by the developer's engineering consultant.

Development inspection staff, in conjunction with the Developer's Consulting Engineer, has conducted all necessary inspections of the municipal services and are now satisfied with the extent of the work. Development Planning staff has advised that deficiencies related a streetscaping item have yet to be completed and are requesting financial securities in the amount of \$5,000 be retained to ensure all works are completed.

Clearances have been received from all pertinent City Departments including Development Planning, Building Standards, Transportation Services and Parks and Forestry Operations, Development Planning, Parks Development, Environmental Services, and Clerks. In addition, the Development Finance & Investments Department has confirmed that all of the City's financial requirements associated with this subdivision have been satisfied.

Accordingly, North Bathurst Developments Ltd. has requested the municipal services constructed in conjunction with the North Bathurst Phase 2 Subdivision Agreement be assumed by the City.

Relationship to Vaughan Vision 2020

The development of this subdivision and the assumption of the municipal services are consistent with Vaughan Vision 2020, which encourages management excellence through planned and managed growth and the maintenance of City assets and infrastructure. This report is consistent with the priorities previously set by Council and the necessary resources have been allocated and approved.

Regional Implications

There are no Regional implications with respect to the assumption of the municipal works within this subdivision development.

Upon the completion of the streetscaping works, the Municipal Services Letter of Credit will be released.

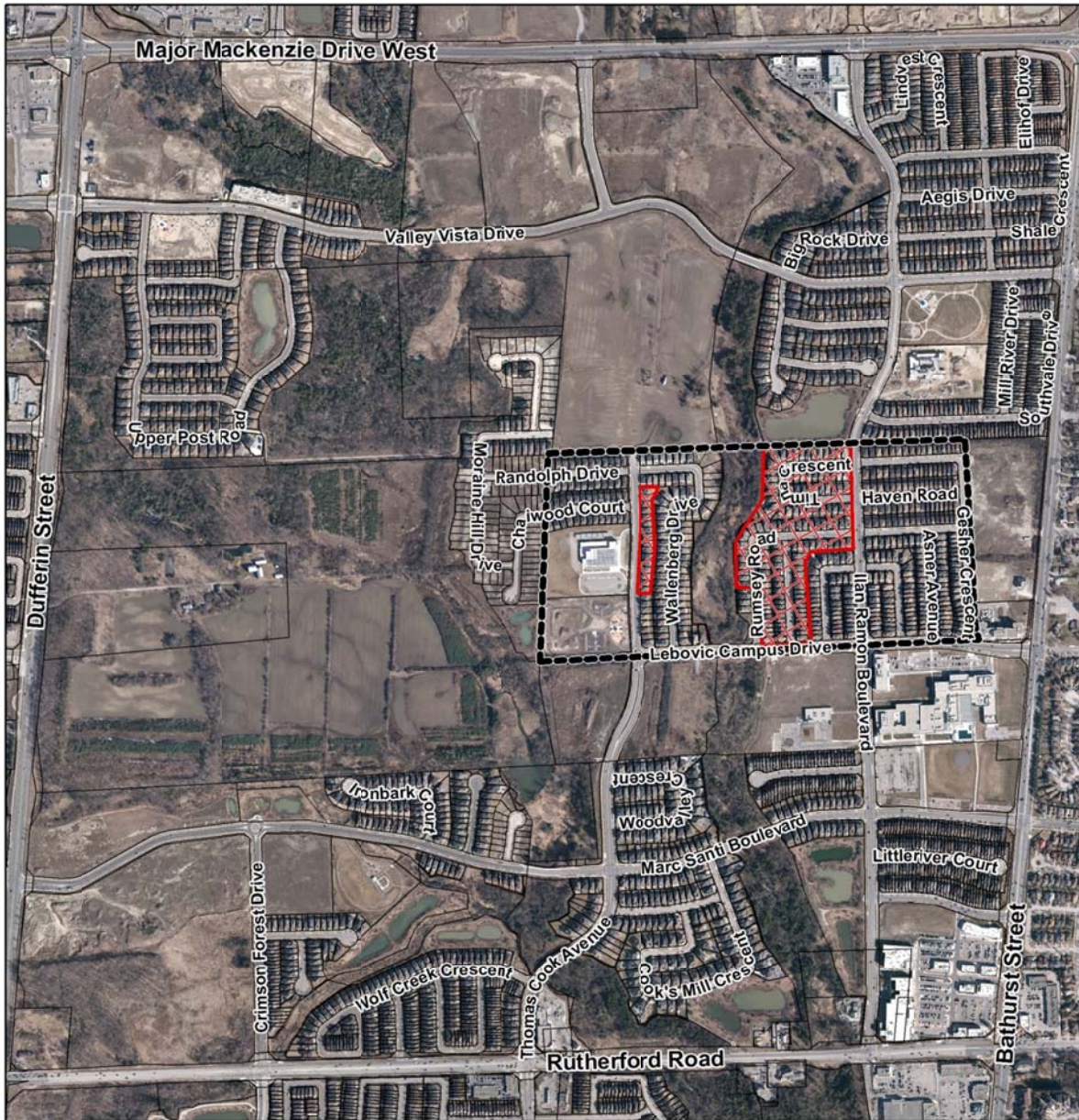

BY-LAW NUMBER 034-2015

A By-law to assume Municipal Services in North Bathurst Phase 2 Subdivision, 19T-95044, Registered Plan 65M-4091.

WHEREAS the Subdivision Agreement between the City of Vaughan and North Bathurst Developments Limited provides for the installation of certain public services.

AND WHEREAS the Commissioner of Public Works has received certification that the services in Registered Plan 65M-4091, have been constructed and installed in accordance with City specifications.

NOW THEREFORE the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. THAT the services in Registered Plan 65M-4091, more particularly described in the Subdivision Agreement between The Corporation of the City of Vaughan and North Bathurst Developments Limited dated June 12, 2008, be and they are hereby assumed as public services.
