

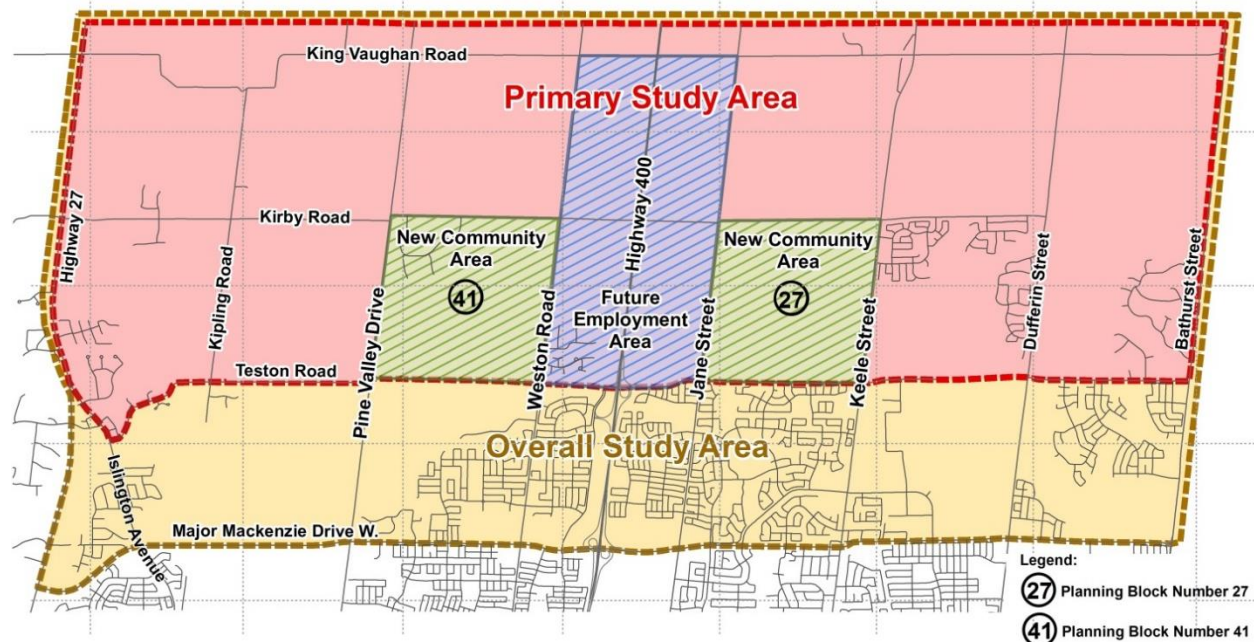


NOTICE OF STUDY COMPLETION

NORTH VAUGHAN & NEW COMMUNITIES TRANSPORTATION MASTER PLAN

THE STUDY

The City of Vaughan has prepared a Transportation Master Plan (TMP) Study to identify policies, programs, and infrastructure to accommodate future growth in the new communities and the surrounding North Vaughan area for a planning horizon of 2031. In close coordination with the Secondary Plan studies for the New Community Areas of Block 27 and 41, (See Map for Study Area) the plan reflects the principles and objectives of the Vaughan Official Plan 2010, the city-wide Transportation Master Plan 2013, and the 2007 Pedestrian and Bicycle Master Plan (currently being updated) to design a compact, vibrant, inclusive, healthy, sustainable, and diverse residential community with a unique sense of place. The study identifies a long-term plan that will guide the city towards a comprehensive transportation network for the Block 27 and 41 Secondary Plan areas that addresses mobility requirements with consideration for existing natural and physical constraints and opportunities from new plans and emerging influences.



THE PROCESS

The North Vaughan & New Communities Transportation Master Plan (NVNCTMP) was conducted in accordance with the master planning process Approach #1 described in the Municipal Engineers Association Municipal Class Environmental Assessment (October 2000, as amended in 2007, 2011 and 2015), including consultation with the public and stakeholders, consideration of all reasonable alternatives, a high level assessment of the impacts on the environment at the network level, evaluation of alternatives highlighting advantages and disadvantages, and full documentation of the process providing a traceable rationale for conclusions reached. The Master Plan process shall satisfy Phase I and II of the Municipal Class EA for recommended infrastructure improvements. The TMP addresses needs and justification at a broad level and recommended EA Schedule B and C infrastructure projects will require further detailed studies as per the Municipal Class EA process.

CONSULTATION

The Transportation Master Plan incorporates public, stakeholder and agency comments received during the study process. Thank you to everyone who participated in the Transportation Master Plan process, your contributions are appreciated. This notice places the completed Transportation Master Plan on record for public review for 30 days at the following locations during regular business hours.
